The purpose of the Clinical Child and Pediatric Psychology Training Council, hereinafter referred to as CCaPPTC, is to promote the advancement of graduate and postgraduate education and training within the fields of clinical child and adolescent psychology and pediatric psychology, hereinafter referred to as CCaPP. CCaPPTC includes representatives from 1) doctoral, predoctoral internship, and postdoctoral programs, 2) involved in the education and training of psychologists, 3) who work with children, adolescents and families, 4) in a range of settings and systems, 5) for a variety of mental health issues and health issues with psychological concomitants, 6) that utilize evidence-based and competences oriented approaches, and 7) that include establishing the scientific bases and applications in service delivery of health service psychology.

Consistent with this purpose, CCaPPTC member programs shall strive to educate and train future clinical child and adolescent psychologists and/or pediatric psychologists to promote human welfare and to advance the growth of CCaPP science and practice.

**Qualifications**

Members of CCaPPTC are clinical, counseling, or school psychology programs offering training in Clinical Child and Pediatric Psychology (CCaPP) at doctoral, internship, or post-doctoral levels. The member programs graduate psychologists capable of functioning as scientific investigators and as practitioners, consistent with the highest standards of professional and health service psychology in ethics and competencies.

In assessing the type of membership for which your program is eligible, please review the “Stages of Education and Training and Levels of Educational Opportunities” figure illustrated on the next page.

This taxonomy (Commission for the Recognition of Specialties and Proficiencies in Professional Psychology, 2012) provides guidelines to assess intensity and breadth of coverage in a training program.

CCaPPTC has two types of membership:

**a) Full Membership** is offered to programs that have a cadre of identifiable faculty in clinical, counseling, or school psychology with have a history of producing professionals with competencies in the science and practice of CCaPP, and provide training at the “*Major Area of Study*” or “*Emphasis*” levels of the Training Taxonomy (see below). Doctoral program CCaPPTC members shall be well-established clinical, counseling, or school CCaPP programs at APA or CPA-accredited universities that offer graduate CCaPP training at the doctoral level. Doctoral internship and postdoctoral training programs shall be programs that offer CCaPP experiences at the “Major Area of Study” or “Emphasis” levels of taxonomy. Program representatives from programs with Full Membership can participate in all aspects of CCaPPTC governance, including running for elected office, voting for candidates for office, and voting on initiatives being considered by the training council.

**b) Associate Membership** is offered to recently established programs that demonstrate commitment to training students with competencies in the science and practice of CCaPP, or those that fall at the “Experience” and “Exposure” levels of the taxonomy (see above). Representatives of programs with Associate Membership are welcomed and encouraged to participate in discussion of initiatives being considered by CCaPPTC, but cannot participate in CCaPPTC governance or vote on initiatives. CCaPPTC expects that Associate Member programs will work to achieve Full Membership status once they meet the aforementioned expectations.

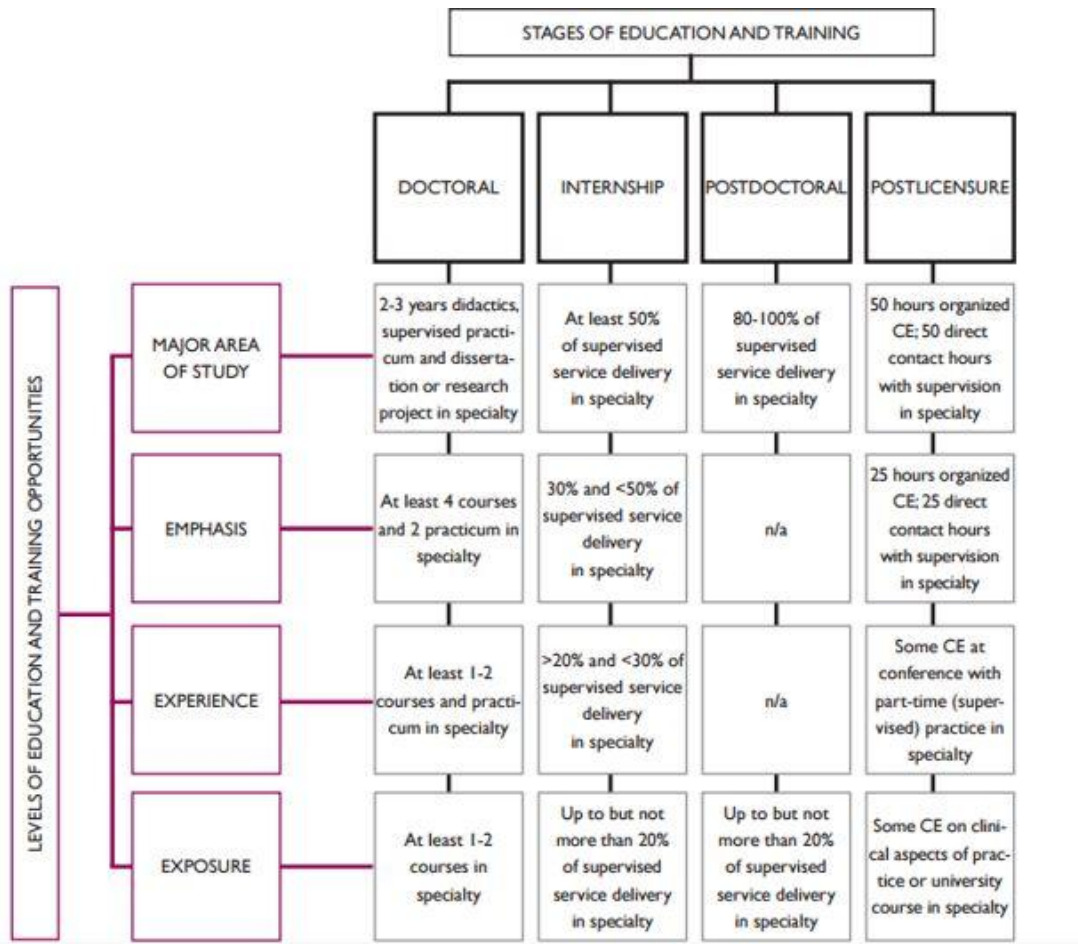

CCaPPTC defines a CCaPP Trainee as a student in the process of completing:

- At least four semester-long courses in CCaPP
- The equivalent of two years of CCaPP practicum training
- A research project or dissertation focused on CCaPP

**Coursework.**

A semester of instruction typically includes 15 weeks and about 2.5 hours/week of classroom contact each semester. Because some programs may not use a semester model, or may offer some CCaPP instruction within non-CCaPP classes, please feel free to estimate proportions of semester contact. For instance, instruction in CCaPP psychopathology that occurs as one third of a general psychopathology class could be listed as “.34.”
